

## Notice of new ASCA regulation regarding non-ASCA registered dogs

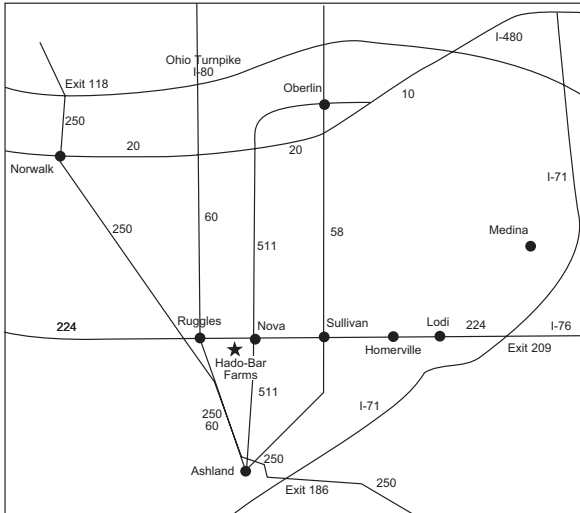
Beginning 1/1/2003 for non-ASCA registered dogs - In order to have ASCA qualifying legs tracked and to receive ASCA titling certificates, each non-ASCA registered dog will be required to have an ASCA Tracking Number.

This is a one-time fee of \$10/dog. At the time of applying for the tracking number, the individual owner must also be an ASCA member (membership is \$5). ASCA membership does not need to be maintained in subsequent years. It will be the responsibility of the owner to identify to ASCA the shows and legs earned when applying for a Tracking Number for those ASCA qualifying legs earned 1/1/2003 until submission of application.

This is being done to help defray cost of processing these titles, to give all those who use ASCA programs a unique ASCA number for ease of tacking, and to reduce the time our staff spends processing competitors who have no interest in ASCA titles. All scores and legs earned before 1/1/2003 are still counted and tracked no matter what. After this time you must apply for the tracking number, but you may do so AFTER the event.

Once Entries close, there will be **NO** refunds. Exceptions will be made for injuries or emergencies on a case by case basis.

Substitutions after Entries close will be allowed with a dog owned by the same person making the original entry with no additional fee. Other substitutions will be allowed with a \$10 fee.

Bitches in season will run in order.

Run order will be pre-drawn and posted the day of the trial.

Move ups are permitted between trials on that day provided that a move-up form is completed and given to the course director. Forms will be provided the day of show.

NOTICE TO EXHIBITORS: This is an ASCA event and will be judged and run by the stockdog trial rules of the Australian Shepherd Club of America. Dogs will be leashed except when trialing and must be brought into the trial arena on leash. Entries will be accepted on a first-come basis and must be made on the ASCA entry form. Run order will be determined by the course director and posted prior to the beginning of the trial. No electrical and/or mechanical training devices will be permitted on the trial grounds. Any questions or problems should be brought to the attention of the course director. The stockdog trial committee is authorized to request that any dog which, in the committee's opinion, represents a hazard to persons, dogs, or property be removed from the premises. Children must be kept under the direct supervision of an adult at all times. No entry fee will be refunded if the show can not open or be completed due to riots, civil disturbances, acts of God, public emergencies or other events beyond the control of BASC. Trialing can be inherently dangerous. Therefore, individuals are responsible for any damage done to or by himself, his family, his visitors, and his critters. ASCA, BASC, HADO-BAR FARM, AND THE OWNERS OF ANY PROPERTY THROUGH WHICH YOU PASS OR PARK, ASSUME NO RESPONSIBILITY FOR ANY DAMAGE OR INJURY.
