Sunday: 2 rounds Jumpers, 2 rounds Regular, 1 round of Gamblers for ALL levels PLUS a second round of ELITE Gamblers

Elite Package (12 runs) = \$120 (all 12 runs)

Pre-Elite Package (11 runs) = \$110 (for dogs who aren't in Elite gamblers)

Pick 8 Package (any 8 runs) = \$80

- **Acceptance of "Day of Trial"/Late Entries:**

We will now accept entries after the "pre-entry" closing date. Late entries will be assessed a \$15 secretarial processing fee per dog. NO EXCEPTIONS! The class entry fees will remain the same as pre-entry fees. We will accept "Day of Show" entries from 6:45 am until 7:15 AM on each trial day, up 350 runs per day. If you 'late enter' a dog for both days, the processing fee will be assessed just once. You may also email or mail the entry after the pre-entry closing date if you don't want to get to the trial so early. But, I must receive it by the Thursday preceding the trial and, should you choose not to attend, you are still responsible for the entry fee.

- **Implementation of "Day of Trial" Change Fee:**

Preliminary and final confirmation letters are sent to all exhibitors who pre-enter. Exhibitors should check their entry information and notify the trial secretary of any changes that need to be made. Changes requested at the trial will be assessed a \$15 secretarial processing fee per dog – regardless of who made the error. PLEASE check your confirmations. This does not include move-ups for Sunday which are received within 30 minutes of the end of the trial on Saturday.

ENTRY INFORMATION:

Eligibility:

ASCA agility trials are open to ALL breeds, including mixes. Your dog does NOT have to be registered with ASCA to enter ASCA agility trials. However, to earn titles, you must have a tracking number or an ASCA Australian Shepherd registration. A tracking number application is included in this premium.

Divisions and Levels:

We will accept "For Exhibition Only" (FEO) entries. Exhibitors may enter FEO at any jump height and level. Please note that FEO scores will not apply to any ASCA agility titles. The Junior Handler Division is open to any dog handled by an exhibitor who is 17 years of age or younger. Dogs entered in the Junior Handlers Division classes **MAY** jump 4" lower than their regular jump height. The Veterans Division is open to any dog age seven (7) or older, or any handler aged 60 or older, or any handler who has a certificate of disability. Dogs entered in the Veterans Division classes **MUST** jump 4" lower than their regular jump height.

Exhibitors may, at their discretion, enter at a level higher than they have titled. If they are registered to receive titles, higher level scores will be applied to unearned lower level titles.

Late Entries:

We will accept entries after the pre-entry closing date, up to published limits. A \$15 secretarial processing fee will be assessed. Day of trial entries will be accepted from 6:45 am until 7:15 am.

Refunds:

Full refunds will be granted prior to the pre-entry closing date. After that time refunds, less a \$15 administration fee, will be granted to injured dogs or bitches in season, if the request is presented to the trial secretary no later than noon on Sunday. No refunds will be issued for amounts under \$10.

Move-Ups:

Day-to-day move-ups will be accepted. Pre-trial move-ups must be received by Monday, November 16th at 5 pm. Titles can be earned under one judge. Twenty points are required for jumpers & gamblers; thirty points for regular.

Height Cards and Measurements:

If your dog's regular division jump height is 16" or lower, you **MUST** be measured or submit a copy of a jump height card from any agility venue that shows the dog's measured height (eg. AKC or NADAC.) Dogs who jump 20" or more need not be measured or present a height card.

Equipment:

Slatted Aframe & Dogwalk and slatless teeter will be used. Jumps, including double, weaves, tunnels, chute, and non-displaceable tire may be used at the judge's discretion. The a-frame shall be set at 5'6". Electronic timing will be used, including start notice and gamble horns.

Prizes and Awards:

Qualifying and 1st through 4th place ribbons will be awarded in each class. Placements will be combined for 20+ and 24" dogs in all divisions. A rosette will be awarded to dogs finishing their ATCH.

ASCA Service Membership and Tracking Number Application

Beginning 1/1/2003 for non-ASCA registered dogs – In order to have ASCA qualifying legs tracked and to receive ASCA titling certificates, each non-ASCA registered dog will be required to have an ASCA Tracking Number. This is a one-time fee of \$10/dog. At the time of applying for the tracking number, the individual owner must also be an ASCA member (minimum membership type of 'Service' is required). ASCA membership does not need to be maintained in subsequent years. **It will be the responsibility of the owner to identify to ASCA the show(s) and leg(s) earned when applying for a Tracking Number for those ASCA qualifying legs earned from 1/1/2003 until submission of application.** Please type or print clearly. Incomplete or illegible forms will be returned.

AGREEMENT

- 1.1 As used here "ASCA" means the Australian Shepherd Club of America, its affiliate clubs and each of their members, officers, directors, employees, show chairs, show committees and agents
- 1.2 Exhibitor/Owner, agree to abide by the rules and regulations of ASCA and any other rules and regulations appearing in the premium for this event.
- 1.3 Exhibitor/Owner certify that the entered dog is not a hazard to persons, dogs or property and that the entered dog's rabies vaccination is current in accordance with the requirement of the state in which the dog resides.
- 1.4 Exhibitor/Owner acknowledge all hazards presented by the event and event premises, including, but not limited to, the condition of floors, stairways, halls, lighting, security measures or lack of, electrical appliances, fittings, show rings, parking areas and the presence of unfamiliar animals and people; exhibitor and owner assume the risk of any harm arising from these
- 1.5 Exhibitor/Owner release ASCA and Buckeye Australian Shepherd Club (including its officers, directors and members and event organizing committee), Four Seasons K9 Athlete Center (including its owners, agents and employees) and will defend them and hold them harmless from all present and future loss, injury, damage, claims, demands, and liabilities involving the entered dog, the event or event premises. Without limiting the generality of the foregoing hold harmless provisions, exhibitor/owner hereby specifically assume sole responsibility for and agree to indemnify and save aforementioned parties harmless from any and all loss and expenses (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damages because of bodily injuries, including death, at any time in consequence of my (our) participation in this event, howsoever such injury, or death, may be caused and whether or not the same may have been caused or may have been alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents or any other persons.
