

ALL ASCA® RULES WILL BE FOLLOWED

NOTE TO OBEDIENCE COMPETITORS: THIS IS NOT A MATCH.

All dogs will be competing for obedience titles through ASCA®. Each entry form must have a current registration number (ASCA® or recognized registry) and be completely filled out, no exceptions. If your dog has earned a title through any other registry, but not ASCA®, your dog will be required to begin in Novice.

Tracking Fee for Non-ASCA® Dogs: All non-ASCA® registered dogs will be required to have an ASCA® Tracking Number. This is a one-time fee of \$10.00 per dog. At the time of applying for the tracking number, the individual owner must also be an ASCA® member (Service Member-\$10.00). ASCA® membership does not need to be maintained in subsequent years. You will be able to apply for a tracking number day of show, if your dog does not have one.

MDR-1 Testing will be available at the shows

Take advantage of group testing for \$51.00 per dog (price increases on July 1 to \$70 for 1-4 tests; 60 for 5 or more)

Testing is simple – several cheek swabs will be done

Knowing your dogs' MDR1 Mutation Status can potentially save his/her life

Australian Shepherds, along with several other mostly collie-type breeds, can carry a genetic mutation that makes them sensitive to certain drugs. Use of those drugs can cause serious neurological illness or death.

Fortunately, there is an extremely accurate DNA test that will let you know whether your dog has this mutation. All you have to do is provide a cheek swab.

Veterans Rules

Dogs at least SEVEN years of age. Veteran Dog and Veteran Bitch will compete for Best Veteran. Best Veteran will compete in BIS.

Best in Show - Saturday Only

Winner of the BOB - Intact, BOB - Altered and BOB Veteran compete for BEST IN SHOW.

Grooming:

There will be limited grooming space under a 20 x 40 tent near the ring however there will be no electric provided. Since there will be both an ASCA agility and obedience trials taking place at the same time, there will be no grooming indoors. We ask if you are just showing in conformation to setup either under the tent or in the designated areas. No set-up will be allowed on Friday night.
