This 2-day sheep and cattle clinic is aimed at dog/handler teams with some previous experience working livestock. Working spot dogs must be at least 9 months old at time of lessos to participate and must be in good physical condition. There will be plenty opportunities to work your dog (2 lessons per day, each lesson may be split into 2 shorter sessions if that is best for the dog). Questions and discussions are encouraged.

Michael and Phyllis McNutt own and operate McNutt Farm raising 100% grass fed and finished Beef and Lamb, and non-GMO pastured chicken. Michael trains and trials Border Collies successfully in USBCHA, competing successfully in many national finals with his and client owned dogs.
